For plywood or OSB subfloors, the edges must be tongue and groove or the use of back blocking is required. The subfloor must be clean and free of construction debris and dirt. The building temperature should be maintained at a 50 °F (10 °C) minimum.
	Priming USG Levelrock SAM-N40 sound attenuation mat is not required prior to installing USG Levelrock Floor Underlayments provided the sound mat is clean and free from construction debris, dirt and dust.
	USG Levelrock <sup>®</sup> Perimeter Isolation Strip must be installed between the sound attenuation mat and walls or floor protrusions. The perimeter isolation strip must be installed so that there is no leakage of USG Levelrock floor underlayment as any breach will compromise the sound system performance. 


